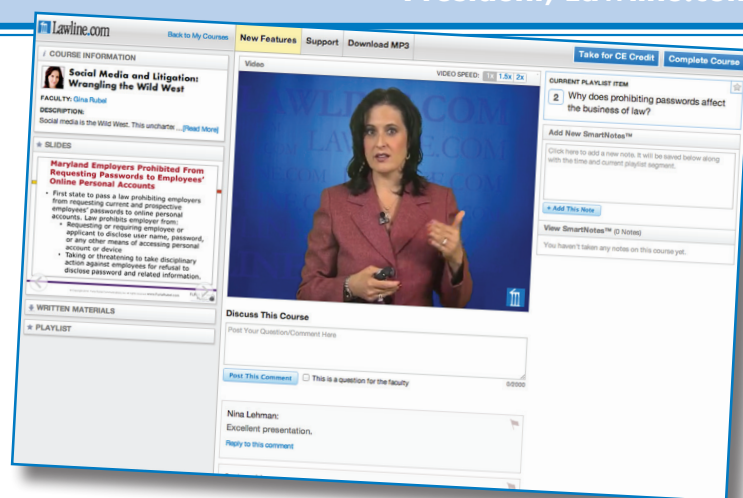

New Course Center

Lawline has matched its prominence in the educational arena by becoming a leader in the realm of internet technology. Its recently-launched course center offers a perfect embodiment of this philosophy.

At the top of the innovation list, the groundbreaking SmartNotes™ feature allows viewers to jot down thoughts, questions, and points of interest that automatically link to the corresponding point of the video. When reviewing the program, they need only click on a particular note to be taken back to the precise second in which the information was disclosed. SmartNotes™ can be stored and dispatched in e-mail format.

Viewers also have the option of skimming through programs at double and triple-speeds, greatly reducing the limitation of time on their efforts to further learning, and a comments section allows viewers to pose questions to the faculty.

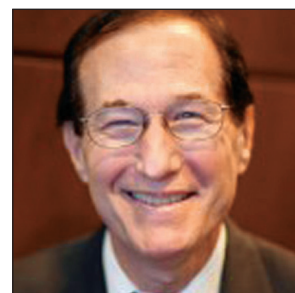
BENJAMIN BRAFMAN

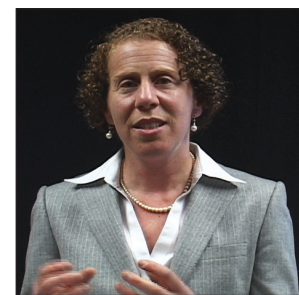
LEE DREXLER

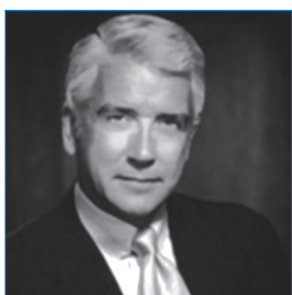
ERICA T. DUBNO

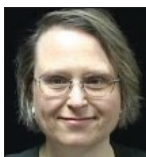

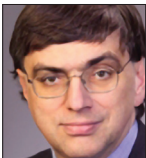

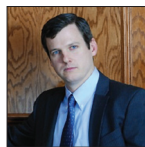

Stephanie Jones – EEOC Practices & Enforcement Procedures



Stephanie Jones is not a stranger either to the myriad forms of discrimination or the resources available to fight them. She has represented employers nationally in a variety of matters, and her pro bono work includes domestic violence litigation on behalf of victims through the Atlanta Volunteer Lawyers Foundation. This exhaustive treatise on the EEOC explores the various types of prohibited discriminatory practices under Title VII, the Age Discrimination in Employment Act, the Americans with Disabilities Act, and the Pregnancy Discrimination Act. It concludes with an enlightening explanation of the EEOC's investigation procedures and a discussion of recent case law.
